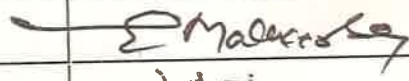
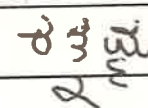

- The office of the Trustee shall become vacant:
 - If the Trustee shall become insolvent or lunatic:
 - If the Trustee shall be convicted of an offence involving moral turpitudes:
 - If the Trustee shall fail to attend three (3) consecutive meetings of the BOARD OF TRUSTEES without leave of absence: Provided that no formal removal of the Trustee on the said ground shall arise automatically.
 - By a removal in the manner hereafter provided.

- c) A Trustee may be removed if the BOARD OF TRUSTEES shall be of the opinion that such trustee be a person is unfit to be a Trustee; provided that before a trustee shall be removed. He shall be furnished with the grounds for removal and shall be called upon the show causes, why he shall not be removed; the removal shall be effected by a "RESOLUTION OF A MAJORITY" of the Trustees passed in a meeting of the BOARD OF TRUSTEES.

8. VACANCIES IN THE OFFICE OF THE TRUSTEES:

- a) Any vacancy occurring for any of the reasons set-out in clause-8 above shall be filled up by the remaining Trustees by appointing such persons as they shall deem fit.
- b) In the event of the number of Trustees shall be reduced to one, such remaining Trustees shall appoint one other person as Trustee. Expecting the appointment of another Trustee, the sole Trustee shall not execute the TRUST to any extent whatsoever. For the purpose of such appointment the sole Trustee shall be deemed to constitute the quorum in a meeting of the BOARD OF TRUSTEES.
- c) In the event there shall be a Trustee in the Board for any reason whatsoever or any remaining Trustee shall be in-capable of acting as such trustee, the Trust shall be deemed to have been dissolved and the provisions of clause 17 hereof shall apply.

9. POWER OF THE TRUSTEES:

- a) The Trustees shall have powers to:-
- i. Solicit, Seek, Revive and Accept any Gifts, Donations, Contributions, endowments and the likes with or without specification for application of such gifts etc.,

13. MEETING OF THE BOARD OF TRUSTEES:

- a) All properties acquired by the TRUST in any manner whatsoever, whether such acquisition be in the name of one or more Trustees or otherwise, shall be the property of the TRUST.
- b) None of the Trustees shall use or employ any of the property of the TRUST for their personal purposes.
